

LEGAL NOTICES – ADULT CONTENT AND PRIVACY

Warning – Adult Content

By continuing to browse or providing consent through the tools provided, the user accepts the use of cookies as indicated in the extended privacy policy, which is always available on the site.

Processing of personal data in sections with profiles and images

Profiles, images, and content published in the site's sections are uploaded voluntarily by users, who declare that they have full access to the data and images used and that they will act in compliance with applicable law. The publication of content referring

to minors, content uploaded without the user's consent, as well as illegal, violent, or unlawful content is prohibited. The platform owner acts as a hosting service provider and removes content reported as illegal according to the procedures established by applicable law.

Reporting Content

Anyone who believes that content posted on the site is unlawful or infringes their rights may report it by sending a message to the contact information listed in the contact section, specifying the content URL, the reason for the report, and any supporting documentation. Reports will be examined promptly.

User Responsibility

The user is solely responsible for their use of the site and any content viewed or uploaded. The Owner is not liable for any use that violates the law, these notices, or the platform's terms and conditions.

Refund Policy

This Refund Policy governs the refund procedures applicable to services offered through the NOQ platform. You acknowledge that digital content purchased on the platform is delivered immediately after payment and that, pursuant to applicable law, the right of withdrawal may be excluded once the content has been used.

However, NOQ may consider refund requests in the following cases:

- Technical malfunctions attributable to the platform that prevent access to purchased content;

Refund requests must be submitted through the dedicated support channel indicated on the website, within a reasonable timeframe of purchase, providing all necessary information for verification.
